**GUIDELINES FOR THE CONDUCT OF PGBI NATIONAL ELECTION DURING THE  
11<sup>TH</sup> NATIONAL CONVENTION 2015**

1. References:

- a) PGBI Constitution and By-Laws
- b) Resolution No. 4 Series of 2012

2. Purpose

This guidelines is for purposes of establishing a more solid National Structure of leadership in accordance to our democratic system of governance as provided in PGBI CBL of 2002 by electing officers for the National Executive Council (NEC) and a separate election for the National Founders Group (NFG)

3. General Policy

Regional Executive Councils and Regional Founders Group from duly affiliated PGBI Chapters, shall designate, from among their officers or selected members, delegates who will be given voting rights. Each region will be allowed Five (5) voting delegates for the Executive Council and Three(3) voting delegates for Founders Group. ( shall we make it 3 for executive and 2 for founders group our 2002 CBL provide only for 5 delegates per region Art 5 sec1 c.)

4. Qualifications

a) General Qualification of Delegates

- Bonafide member and member in good standing of an affiliated PGBI Chapter to the National Office as attested by the National Headquarter
- Was not convicted of any criminal, administrative or cases involving moral turpitude.

b) Qualification of Candidates for National Executive Council

- Bonafide member and member in good standing of an affiliated PGBI Chapter to the National Office as attested by the National Headquarter
- Was not convicted of any criminal, administrative of cases involving moral turpitude.

- Has accepted his nomination from the Regional Officers or, as an incumbent officer of the regional executive council, has filed his certificate of candidacy prior to the conduct of election.
  - Founders who opted to run for Executive Council position can no longer be a voting delegate for Founders Group Election.
- c) Qualification of Candidates for the National Founders Group
- Bonafide member and member in good standing and the Founder of an affiliated PGBI Chapter to the National Office as attested by the National Headquarter
  - Was not convicted of any criminal, administrative of cases involving moral turpitude.
  - Has accepted his nomination from the Regional Founders or as an incumbent officer of the Regional Founders Group, has filed his certificate of candidacy prior to the conduct of Election.

**5. PROCEDURES**

- a) The National President shall appoint a Chairman, Vice-Chairman and members of the National Election Committee before the date of the National Assembly on April 19, 2015
- b) The Chairman of the Election Committee shall administer the conduct of election.
- c) The Election shall be conducted thru ballots to be provided by the ELECOM to the voting delegates
- d) All disputes regarding the qualification of delegates and candidates have to be resolved before the conduct of election.
- e) All protest regarding the result of election have to be resolved before the end of the convention/ assembly.
- f) The decision of the Election committee on all disputes and protest shall be final.

**6. PROCLAMATION OF WINNERS**

- a) The Election Committee shall immediately proclaim the winners after resolving election protest that may arise.

**7. ELECTION OF NATIONAL OFFICERS**

- a) The winners of the National Executive Council election together with the incumbent President and the incumbent Vice President shall immediately convene to Elect from among themselves a National President and National Vice-President.

- List of winners for the National Executive Council
  - List of winners for the National Founders Group
  - List of candidates
  - List of delegates
  - Record of disputes / protest and the decisions made thereto.
